### DEER HUNTING AGREEMENT

This form is a contract and information sheet for \_\_\_\_\_ hereby refer to as ". Please complete, sign, date and return to SNAKE RIVER OUTFITTERS, LLC, at the address provided above. Verbal Agreements will hold your reservations for fourteen (14) days. We must have a deposit (which is non-refundable) and this completed contract, to insure this reservation for the dates of \_\_\_\_\_ to \_\_\_\_\_

Your trip will consist of five (5) days; you will be expected to arrive the day prior to your first day of scheduled activity and to leave the day after your trip ends unless other arrangements have been made in advance.

You will be engaging in the activity of hunting \_\_\_\_\_ **MEDAL**. The term \_\_\_\_\_ Medal is designed to harvest bucks which attending guide feels fit the criteria for this category. You will be expected to purchase all the proper licenses for this activity they may be purchased over the counter upon arrival with a **valid driver's license and hunter safety certificate** if born after 1949.

This final payment is to be paid by cashier's check, travelers check or cash. PERSONAL CHECKS will only be accepted if received three weeks prior to arrival date.

It is understood by all parties that the live estimate of score or live estimate of medal distinction, by attending guide is **ONLY** an estimate. Snake River Outfitters assumes all responsibility of estimations by guide. All decision of harvest are solely the responsibility of Hunter regardless of score. Snake River Outfitters assume no responsibility for providing access to bucks which achieve a higher category than one stated above.

Our fully serviced hunts will provide all: guiding (2/1 ratio) game care, airport pickup and return (as needed) to the Steamboat Springs airport. You, the client, will be responsible for your own clothing, ammunition, proper licenses, and all processing and taxidermy costs, a gratuity of 8 to 10 % of hunt cost is recommend for guide compensation. We also recommend that all clients bring at least one large cooler to take their game home in. Shipping game by freight has proven to be expensive and not very reliable.

Your trip with us will involve the using of primarily 4x4, foot, ATV's, and horses. If you have any reasons for not using any of these items please inform Snake River Outfitters, LLC, of this. The risks associated with primitive conditions of the hunt area, the elevation, weather conditions, unavailability of medical attention, travel by foot, vehicle on horseback, and the handling of firearms in a hunt area by persons within or outside of the outfitter's camp(s) are substantial; nonetheless, you desire to engage in the activities.

## RELEASE AND INDEMNIFICATION

Pursuant to section 12-55-5-105 9(1)(c) and (1) (d) outfitters are required to be bonded and possess a minimum level of liability insurance and all activities are regulated by the director of the division of registration in the department of regulatory agencies.

However in consideration of being permitted to access lands owned or controlled by Snake River Outfitters, LLC, Thomas Patrick Grieve, I, for myself, my heirs and personal representatives do hereby fully and forever release, waive and discharge and covenant not to sue Snake River Outfitters, LLC, Thomas Patrick Grieve and others associated therewith, including but not limited to their managers, members, employees or agents and all persons whomsoever directly or indirectly liable or alleged to be liable for any and all claims, demands, actions, causes of action, damages, costs, loss of services, expenses (including attorney fees) and all other claims of damage whatsoever and of whatever nomenclature, both in law and in equity, on account of or in any way resulting from personal injuries, conscious suffering, death or property damages sustained by me and arising out of or associated with my accessing lands owned, leased or controlled by Snake River Outfitters, LLC, Thomas Patrick Grieve, or from any activities associated with my use of such property, including but not limited to all claims for negligent acts and excepting only injury or death resulting from willful misconduct.

I covenant and agree to assume the full responsibility for and risk of bodily injury, death or property damage relating to the use of property or lands owned, leased or controlled by Snake River Outfitters, LLC, Thomas Patrick Grieve, and expressly agree that this release is intended to be as broad and inclusive as permitted by the laws of the State of Wyoming and State of Colorado.

I further covenant and agree to indemnify and hold harmless Snake River Outfitters, LLC, Thomas Patrick Grieve, and all others associated therewith, including but not limited to their managers, members, employees or agents and all other persons whomsoever, directly or indirectly, liable from any and all claims, demands, actions, causes of action, damages, costs, loss of services, expenses (including attorney fees) and all other claims of damage whatsoever and of whatever nomenclature, both in law and in equity, on account of or in any way resulting from personal injuries, conscious suffering, death or property damage sustained by me and arising out of my accessing lands owned, leased or controlled by Snake River Outfitters, LLC, Thomas Patrick Grieve,, including but not limited to all claims for negligent acts and excepting only injury or death resulting from willful misconduct.
